### 1. Activities Completed since April 2024

- Reviewed activities since last meeting, which included the Disaster Forum, showcasing a Regional Emergency Coordination Centre and Incident Command, Regional workshops, Bow Valley Wildfire & Emergency Preparedness Day Event, Regional Evacuation Modelling and Plan kickoff, RECC Orientation exercise, as well as the 2025 G7 Integrated Exercise.
- Discussed our continued focus of Emergency Management training with team members on ECC activation, role specific training as well as conducted a Regional Evacuation workshop.

### 2. Regional Emergency Management Workplan and Update

- Provided a recruitment update which included hiring a Regional Emergency Management Coordinator which is a shared position between Banff and Canmore, working in both communities. This will be a Town of Banff employee and will be "contracted" out to Town of Canmore.
- Reviewed the upcoming workplan for Emergency Management events. Focus on Reentry and Recovery planning, Evacuation plan updates, community engagement, internal training and potential grant opportunities.

## 3. G7 Regional Emergency Coordination Centre

- Discussed our learnings from the tabletop exercise in February as well as the functional exercise held in May.
- Provided details on the planned activation of a Bow Valley Regional Emergency Coordination Centre during June 9-18th, 2025. This will include monitoring, real-time collaboration and will provide a central location to co-locate regional critical infrastructure.
